
Dual 0-10VDC-to-Casambi 2-Channel Dimmer with Dig3 Digital ON/OFF with a Casambi CBM003 Long Range Radio

Product Description

10casLR3 is a Bluetooth controllable, Casambi enabled, two channel analog 0-10VDC input dimmer that allows connection to a standard 0-10VDC analog dimming master controller to a Casambi network. While the Casambi manufactured CBU-A2D is intended to connect to analog controlled fixtures, the 10cas is the "other side", allowing for standard 0-10VDC controllers to be utilized with Casambi networks. The 10cas is connected between a 12-24 VDC Class 2 power supply, and a 0-10VDC master with one or two channels. In addition a single digital, dry contact is supported with 3-way operation modes.

10cas can implement up to three Casambi pushbutton devices, making it an ideal partner for tunable white (TW) applications. Multiple 10cas devices can be used in the same network to control different fixtures, channels or zones since the two channels of control can be mapped using the Casambi mobile application. Two channels are 0-100% dimming capable, with a single configurable digital ON/OFF from Dig3.

10cas can be configured with the Casambi app which can be downloaded free of charge from Apple App Store and Google Play Store. Different Casambi enabled products can be used from a simple single luminaire direct control to a complete and full featured light control system where many units automatically form an intelligent mesh network.





Installation

Connect a Class 2 power supply with 12-24 VDC output voltage to the input connector of 10cas. Make sure not to use a constant current LED driver and make sure that the cable polarity is correct. The product has two 0-10VDC analog positive input connections, plus one common (RETURN) ground. Connect the 0-10VDC load wires to a 0-10VDC master of your choice to give you 0-10VDC control of your Casambi lighting network.

10cas can be mapped just like **Pushbuttons** are mapped in the Casambi application. Once you add the 10cas to your Casambi network, navigate to the “More” button at the bottom of the app. Then press “Switches”, where the 10cas will be shown. Press on the 10cas that you want to configure, and select each of the three pushbutton items. The first two are analog 0-10V and can be used to dim Elements, the third is digital only. Configure the two pushbuttons to control a Casambi element by pressing on “Not in Use” and then select what the pushbutton is to control, most likely “Controls and Element”, which then you can select a certain Element to control. Note at the bottom of this screen there are eight user programmable parameters—High and Low Trim, Hysteresis, and Dimming Curve. These allow fine tuning of the bottom and top analog voltage in, and hysteresis allows for managing inputs that may be noisy, plus a log dimming option that affects both analog channels. Be sure to press “Done” at the top right to save the configuration.

The 3rd input is digital only, no dimming. The digital input is dry contact, do not power it! Simply open or short that to ground terminal provided. Normal, inverted and MultiSwitch operations are offered. Normal wants a short to go “on”, inverted a short to go “off”, while MultiSwitch allows multiple 10casLR3 units to be used in tandem to work like 3-way switches. The 10 gang sets allow for up to 10 difference pairing of 10casLR3 units in this mode.

Range

The range between two 10cas’s or between a 10cas and a smart phone can vary depending on obstacles and surrounding material. In open air the range between two 10cas can be in excess of 200 ft, but if the unit is encapsulated into a metal structure, the range can be only few feet. Therefore, thorough testing is high suggested. Casambi uses mesh network technology so each 10cas acts also as a repeater. When testing the network, it is important to test that each unit can be controlled from any point of the network covered area.

10cas should not be placed in a metal enclosure, such as metal junction boxes. Metal will attenuate radio signals which are crucial to the operation of the product. If the product will have to be installed into a junction box, make sure to use a plastic junction box. 10cas is an ETL Listed Open-Type device which means that it will have to be used together with a Class 2 power supply with maximum output power of 100 VA. The product can be installed outside of junction box. Make sure to comply with National Electric Code in installation and when selecting installation wires.
